ON SOME AMENDMENTS TO DECISION OF THE COUNCIL OF MINISTERS NO. 538, DATED ON 26.05.2009, "ON LICENCES AND PERMITS HANDLED BY OR THROUGH THE NATIONAL LICENSING CENTRE (NLC) AND OTHER COMMON SUB-LEGAL REGULATIONS"

Based on article 100 of the Constitution, and articles 15 and 36 of law no. 10 081, dated 23.02.2009, "On licences, authorizations and permits in the Republic of Albania", on a proposal of the Minister of Economy, Trade and Energy, the Council of Ministers

DECIDED:

- "c) The time limit for taking this decision shall be 15 days."
- 2. Sub-paragraph "b", paragraph 6, concerning category I.3, shall be amended as follows:
- "b) The time limit for taking this decision shall be 30 days."
- 3. Paragraph 10, concerning subcategory II.2.A, shall be amended as follows:
- "10. The time limit for taking this decision shall be 20 days."
- 4. Paragraph 15, concerning subcategory II.1.B, shall be amended as follows:
- "15. The time limit for taking this decision shall be 15 days."
- 5. Sub-paragraph "b", paragraph 6, regarding activity II.2.A.1 under the category II.2.A, shall be amended as follows:

- "b) The time limit for taking this decision shall be 15 days."
- 8. Sub-paragraph "b", paragraph 11, concerning sub-category II.3.B, shall be amended as follows:
- "b) The time limit for taking this decision, according to sub-paragraph "a", paragraph 11 above, shall be 15 days."
- 9. Sub-paragraph "b", paragraph 13, concerning sub-category II.3.C, shall be amended as follows:
- "b) The time limit for taking this decision, according to paragraph 13/"a" above, shall be 10 days."
- 10. Sub-paragraph "c", paragraph 8, concerning sub-category II.5.A, shall be amended as follows:
- "c) The time limit for the other institutions to take this decision shall be 15 days."
- 11. Sub-paragraph "b", paragraph 12, regarding activity II.5.B.1 and II.5.B.2 under the subcategory II.5.B, shall be amended as follows:
- "b) The time limit for taking this decision shall be 15 days for the activities under code II.5.B.1, and 10 days for the activities under code II.5.B.2."
- 12. Sub-paragraph "b", paragraph 17, concerning sub-category II.5.C, shall be amended as follows:
- "b) The time limit for taking this decision shall be 10 days."
- 13. Sub-paragraph "b", paragraph 9, concerning sub-category II.6.B, shall be amended as follows:
- "b) The time limit for taking this decision shall be 15 days."
- 14. Sub-paragraph "b", paragraph 9, concerning sub-category II.7.B.1, shall be amended as follows:
- "b) The time limit for taking this decision shall be 15 days."
- 15. Sub-paragraph "b", paragraph 13, concerning sub-category III.2.B, shall be amended as follows:
- "b) The time limit for taking this decision shall be 10 days."
- 16. Sub-paragraph "b", paragraph 5, concerning category III.3, shall be amended as follows:
- "b) The time limit for taking this decision shall be 20 days."
- 17. Sub-paragraph "b", paragraph 6, concerning category VII.1, shall be amended as follows:

- "b) The time limit for taking this decision shall be 10 days."
- 18. Sub-paragraph "b", paragraph 6, concerning category VII.2, shall be amended as follows:
- "b) The time limit for taking this decision shall be 10 days."
- 19. Sub-paragraph "b", paragraph 7, concerning sub-category IX.1.A, shall be amended as follows:
- "b) The time limit for taking this decision shall be 2 weeks."
- 20. Sub-paragraph "a", paragraph 11, concerning sub-category IX.1.B, shall be amended as follows:
- "a) The time limit for the other institution to take this decision shall be 15 days."
- 21. Sub-paragraph "c", paragraph 8, concerning sub-category X.1.B, shall be amended as follows:
- "c) The time limit for taking this decision shall be 10 days."
- 22. Sub-paragraph "c", paragraph 8, concerning sub-category X.2.B, shall be amended as follows:
- "c) The time limit for taking this decision shall be 10 days."

This decision enters in force after its publication in the "Official Journal" and becomes effective as of January 1, 2010.
