DECISION

No. 26, date 20.1.2016

ON AN ADDITION TO THE DECISION NO. 538, DATE 26.5.2009, OF THE COUNCIL OF MINISTERS "ON THE LICENSES AND PERMITS THAT ARE PROCEEDED FROM OR THROUGH THE NATIONAL LICENCING LICENSING CENTRE (NLC) AND SOME OTHER COMMON SUB-LEGAL ADJUSTMENTS"

Based on the Article 100 of the Constitution of the Republic of Albania, Articles 15 and 36 of the Law no. 10 081, date 23.2.2009, "On the licenses, authorizations and permits in the Republic of Albania", upon the proposal of the Minister for Economic Development, Tourism, Trade and Entrepreneurship, and the Minister for Transport, and Infrastructure, Council of Ministers

DECIDED:

In Annex 1, attached to Decision no. 538, dated 26.5.2009, of the Council of Ministers, the following changes and additions are made:

- 1. In letter "b", point 2, sub-category VII.5, the designation "For the operation of the withdrawal of solid and oily residues in the Durrës Port and in the respective line with the code VII.5.2" shall be replaced by the designation "On the activity of withdrawing solid and oil waste at the Port Authority in Durres, Porto Romano and their respective lines, with code VII.5.2".
- 2. 1. In the letter "c", point 2, sub-category VII.5, the designation "For the operation of the withdrawal of solid and oil waste in the seaports of Vlora, Shengjin, Saranda and the relevant lines, with code VII. 5.3 "shall be replaced by the designation" For the operation of the withdrawal of solid and oily residues in the other seaports of the Republic of Albania and their lines, with code VII.5.3 ".
- 3. After letter "e", point 2, sub-category VII.5, the letters "ë" and "f" are added with the contents, as follows:
- "ë) "On the execution of the linesman activity" with code VII.5.6;
- a) "On the execution of the fuel supply activity, for consumption of the ships in ports and lines" with the code VII.5.7.".

Item 3 of sub-category V11 5, changes with the following content:

"3. Licenses of subcategories VII.5.1, VII.5.2, VII.5.3, VII.5.4, VII.5.5, VII.5.6 and VII.5.7 are treated according to group III. The accompanying and supporting documents submitted by the applicant, the meaning of the type of activities, the other institution, the procedure for reviewing the

request and the deadlines for responding to the NLC for a request that has been accepted in the first phase by NLC, for the sub-categories VII.5.1, VII.5.2, VII.5.3, VII.5.4, VII.5.5, VII.5.6 and VII.5.7 are the respective ones, as defined in law no. 9251, dated 8 July 2004, "The Maritime Code of the Republic of Albania", as amended, and its sub-legal acts for its implementation. ".

This decision enters into force after the publication in the Official Journal.
