

DECISION
Nr. 301, date 5.4.2017

ON SOME AMENDMENTS AND ADDITIONS IN THE DECISION NO. 538, DATE 26.5.2009, OF COUNCIL OF MINISTERS , “ON LICENCES AND PERMITS HANDLED FROM OR BY MEANS OF NATIONAL LICENCING CENTER AND SOME OTHER COMMON SUBLEGAL REGULATIONS ”, AMENDED

Pursuant to Article 100 of the Constitution, Articles 15 and 36 of the Law No. 10081, dated 23 February 2009, "On licenses, Authorizations and Permits in the Republic of Albania", Article 32 of Law No.8872, dated 29.3. 2002, "On Vocational Education and Training in the Republic of Albania", as amended, Articles 2, 22 and 24 of the Law No. 69 / 2012, "On the pre-university education system in the Republic of Albania", as amended, Law No. 75/2014 “On Private Service the Physical Security” , Law no. 10448, date 14.7.2011, “On environmental permits ”, amended , and law no.8378, date 22.7.1998, “Road Code of Republic of Albania ”, as amended, with the proposal of the Minister of Economic Development, Tourism, Trade and Enterprise, Minister of Education and Sports, Minister of Transport and Infrastructure, Minister of Internal Affairs, Minister of Environment and Minister of Social Welfare and Youth, Council of Ministers

DECIDED:

The following changes and additions are made on Decision no .538,date26.5.2009,of Council of Ministers, amended :

1. In annex 1, field I “National Security, public order and civil protection ”, category I.3, the following amendments and additions are made:

a) The title of category I.3 “Service of protection and /or physical security” is substituted with “Private Service of Physical Security ”.

b) After letter “b, point 2,chapter I, it is added letter”, with the following content:

“c)“The Center of Private Training for employees of Private Service of Physical Security”, code I.3.C.”.

c) Point 3,chapter I, is amended as follows:

“3. The licenses for the three subcategories are on unlimited term ”.

c) Title of chapter II, “Licensing of activities of subcategory I.3.A and I.3.B” is substituted by “Licensing of activity of subcategories I.3.A , I.3.B and I.3.C.”.

d) Point 4, chapter II, is amended as follows :

“4. The special licensing criteria, as well as respective types of evidence and accompanying documents for the subcategories A, B and C are provided in the following table 1.”.

dh) Point 5 chapter II, is amended , as following:

“5. The licensing of activity for the three subcategories is done according group III.”.

2. In annex I, field III ,“Environment and basic environmental resources” point 2, category III. 1. “Impact on environment”, point 2, category III.1 “Impact on environment ”, is amended, as follows :

“2. Permits of impact on environment are divided in three subcategories as follows:

- a) “Environment Permit type C”, code III.1.A;
- b) “ Environment Permit type B”, code III.1.B;
- c) “Environment Permit type A”, code III.1.C.”.

3. In annex I, field VII, “Transport”, letters “a” and “b”, of point 3, of subcategory VII.3 “Driving School ”, are amended as follows :

“a) “Driving school on providing driving license”, code VII.3.A.1, in which the following categories are included:

- i) category AM;
- ii) category A1;
- iii) category A2;
- iv) category A;
- v) category B1;
- vi) category B;
- vii) category BE;
- viii) category C1;
- ix) category C1E;
- x) category C;
- xi) category CE;
- xii) category D1;
- xiii) category D1E;
- xiv) category D;
- xv) category DE.”.

“b) “Driving School for the preparation of applicants seeking to obtain Vocational Training Certificate (VTC)”, code VII.3.A.2, in which the following categories are included:

- i) VTC for goods transport;
- ii) VTC for passengers transport.”.

4. In annex I, field IX “Education and Science ”, subcategory IX.1.A, the following amendments and additions are made :

a) Point 4, chapter I, is amended as follows:

“4. Activities of subcategory A are specified according the levels and/or educational profile:

- a) “Preschool Education (kindergarten)”, code IX.1.A.1;
- b) “Elementary Education ”, code IX.1.A.2;
- c) “Primary secondary education ”, code IX.1.A.3;
- ç) “High secondary education (high school)”, code IX.1.A.4;
- d) “Oriented secondary education ”, code

IX.1.A.5;

dh) “Vocational professional education ”, code IX.1.A.6;

e) “Technical secondary education ”, code IX.1.A.7;

ë) “Special Education ”, code IX.1.A.8.”.

b) Point 7, chapter II, is amended as follows :

“7. Licensing of activities “Pre-school education (kindergarten)”, code IX.1.A.1; “Elementary education ”, code IX.1.A.2; “Primary secondary education”, code IX.1.A.3; “High Secondary Education(high school)”, code IX.1.A.4; “Oriented Secondary Education”, code IX.1.A.5 and “Special education”, code IX.1.A.8, is done according group III.

a) The other institution is the Ministry of Social Affair and Youth and the decision on its behalf is taken by Commission of Examination of Licenses Applications and/or Certificate for Education Services , which is established and functions in accordance with order of minister. The decision is based in evidences of licensing documents and by inspections in field and direct assessment of fulfillment of respective licensing criteria.

b) The term for taking the decision is 2 weeks.

c) The request in NBC is accepted if it is filed at least 3 months in advance from the beginning of the academic year”.

c) After point 7, chapter II, it is added point 7/1, with the following content:

“7/1. Licensing of activities “Secondary vocational education ”, code IX.1.A.6, and “Secondary technical education ”, code IX.1.A.7, is done according group III.

a) The other institution is the Ministry of Social Affair and Youth and the decision on its behalf is taken by Commission of Examination of Licenses Applications and/or Certificate for Education Services , which is established and functions in accordance with the order of minister. The decision is based in evidences of licensing documents and by inspections in field and direct assessment of fulfillment of respective licensing criteria.

b) The term for taking the decision is 2 weeks

d) The request in NBC is accepted if it is filed at least 3 months in advance from the beginning of the academic year”.

This decision enters into force after publication in the Official Gazette.
